It is understood that any permit issued on this application will not grant any right or privilege to perform any electrical work that is not in conformance with the City of East St. Louis, Electrical Ordinance, codes and regulations. The application further agrees to notify the City's inspection Department at the appropriate stages during the work being performed to arrange for inspections.

Permits shall be issued for all residential property owners who can demonstrate that they can successfully perform the work according to the City and National Codes. Work on such property is limited to residential dwellings up to amps.

Any person violation any provisions of this section or any part thereof, shall be fined in the amount of not more than \$500.00. Each day such violation is committed or permitted to continue to continue shall constitute a separate offense and shall be punishable hereunder as such.
